**ORDER**

As per the reference (1) above this department had issued notification, vide reference (2) regarding General Transfer guidelines. The transfer guidelines for 2019 was ratified by Government vide reference (3) above. Accordingly this department had published the draft Rank list for all subjects vide reference (4) cited above. Smt.Moti.K.R, Vocational Teacher in MLT has filed OA 1780/19 in Hon'ble Administrative Tribunal raising objections against the rank list. Vide reference (5) above the Hon'ble KAT has ordered to consider and pass appropriate orders on vide reference (6) above, i.e. the A4 objections of the applicant.

Vide reference (6) above Smt.Moti.K.R has raised objection against Smt.Preetha.R.Babu, Vocational Teacher in Medical Laboratory Technology who being settled in Thiruvananthapuram is continuing in Thiruvananthapuram for the past 6 years showing that her home town is Ernakulam in the online application for transfer. Thus Smt.Preetha.R.Babu is placed above Smt.Moti.K.R in Rank list and she is not being transferred anywhere. Also she has already

claimed her SC priority by which she had been retained for the past 6 years in Thiruvananthapuram District.

In this circumstances in compliance with the Hon'ble Kerala Administrative Tribunal order vide reference (5) above, Smt.Preetha.R.Babu, Vocational Teacher in Medical Laboratory Technology is transferred and placed at Govt.VHSS Keezhuparambu. The complaints or objections raised by Smt.Moti.K.R against the rank list cannot be considered at this juncture. Rank list has been prepared completely based on norms & guidelines for General Transfer issued by Government vide reference (1) above. Employees, who even though have not completed 3 years in the present school, can apply for transfer to their home station and if they have more outstation service they may come on top in the rank list. Deviprasanth, Muraleedharan.K., has more outstation service than the applicant. Hence the applicant cannot be placed above the teachers who has more outstation service.


Thus the Hon'ble Kerala Administrative Tribunal order on OA 1780/19 is hereby complied with.
